Net Generation Provider 2018 Tablet Promotion from USTA Mid-Atlantic
Official Rules

Abbreviated:

1. Be a registered and approved Net Generation provider within the USTA Mid-Atlantic Section. Register/complete process at www.netgeneration.com
2. Agree to the provider standards in your provider profile. Once logged in to Net Generation, access the Provider Menu and click "Edit Profile." The checkbox to accept the provider standards is at the bottom of the screen.
3. Post a public youth tennis program on Net Generation by July 27, 2018. To be eligible, your program must start between July 1, 2018 and September 30, 2018.
4. USTA Mid-Atlantic will award up to 50 tablets to eligible providers.

Prizes:

Fifty tablets (50) will be awarded at the conclusion of the promotion period. Approximate retail value of each tablet is \$150.

OFFER VOID WHERE PROHIBITED OR RESTRICTED BY LAW. By participating, you agree to be bound by these rules and represent that you satisfy all eligibility requirements.

1. **ELIGIBILITY:** The Net Generation Provider Tablet Promotion (the "promotion") is open only to approved Net Generation providers within the USTA Mid-Atlantic Section, who are 18 years of age or older at the time of entry and an approved Net Generation provider that has met the criteria above. Employees and other representatives of USTA Mid-Atlantic Section ("USTA MAS") or its affiliates, distributors, agencies, and members of each of their immediate families are not eligible to enter or win. Offer is void where prohibited or restricted by law.
2. **TIMING:** The promotion period begins June 20, 2018 at 12:01 AM EASTERN and running through July 27, 2018 at 11:59 PM EASTERN. If you met the qualifications above between 6/20/2018 and 7/27/2018 and were one of the first fifty (50) to do so, you will be notified for a prize. Up to fifty (50) tablets will be awarded to qualified entries that were listed during the promotion period. USTA MAS reserves the right to not award tablets or award fewer tablets following the promotion period if eligibility is not met by participants.
3. **SELECTION OF WINNERS:** First fifty (50) qualified providers will be notified by August 1, 2018. USTA MAS reserves the right, at its discretion, to disqualify any entry that does not

comply with the rules or to disqualify any individual (and their entry) who tampers with the entry process.

4. WINNER VERIFICATION: Potential winners will be notified by EMAIL. If the winner is unreachable, ineligible or fails to claim the prize within twenty-four (24) hours after being contacted, such winner will forfeit the prize and the prize may be awarded to another winner, at the discretion of USTA MAS. In the event of disqualification, USTA MAS will award the prize to an alternate winner by random drawing from among the remaining applicable eligible entries.
